#### **BIOGRAMS OF THE CONFERENCE PANELISTS**

## Wojciech Cetnarski



President of the Management Board of the Polish Wind Energy Association (PSEW). He became the head of the Polish Wind Energy Association (PSEW) in April 2013, after 13 years of activity in the RES industry in Poland. During that time, he held a number of managerial positions and successfully ran his own investment consultancy and management company, "Wojciech Cetnarski Consulting". He is also the president of the board of Wento sp. z o.o. - a specialized investment company established by Enterprise Investors, a leading company managing private equity and venture capital funds. Between 2009 and 2012 he was a member of the Management Board of Norvento Polska sp. z o.o. As a representative of a strategic investor implementing investment projects in renewable energy, the company prepared wind projects with a total capacity of approximately 70 MW in Poland. Until December 2005, he was the vice president of Polish Energy Partners S.A. and the president of Saturn Management sp. z o.o. As one of the founders, from July 1997 to December 2003, he was the President and CEO of Polish Energy Partners S.A. He studied at the Faculty of Aviation Engineering at the Sapienza University of Rome and Civil Engineering at the Warsaw University of Technology. Fluent in English, Italian and Russian.

#### **Rafał Gawin**



President of the Energy Regulatory Office. He holds a PhD degree in Technical Sciences in the field of electrical power engineering and energy management. His career has been dedicated to the energy sector since the very beginning. At the Energy Regulatory Office since 2004. Civil servant since 2007. He has experience in supervising energy companies, particularly in the field of financial reporting and audit as well as investment and development. He has extensive experience in international cooperation as a member of the working groups of the European Regulators Group for Electricity and Gas (ERGEG) and the Agency for the Cooperation of Energy Regulators (ACER); member of the Committee for Cross-Border Electricity Trade (European Commission) and expert of the Commission in TAIEX programs (training for the EU's neighbouring countries and EU candidate countries). Lecturer. As an expert in energy law, he is the author of many publications and studies on the functioning of electricity markets, including grid access rules, system balancing mechanisms and regional electricity markets, co-author of the commentary to the Energy Law.

Between 2015 and 2018 he headed the Department of Environment at the Permanent Representation of the Republic of Poland to the European Union in Brussels, where he negotiated draft legislation in the field of environment and climate in Council working groups. In 2018, he was the chief negotiator of the Polish COP24 Presidency in Katowice, preparing a package of decisions implementing the Paris Agreement, the so-called Katowice Rulebook. From 2019, he again headed the Department for Environment at the Permanent Representation of the Republic of Poland to the EU.

In the 8<sup>th</sup> term Sejm, he worked with the Committee on Energy and State Treasury, as well as founded and chaired the works of the Parliamentary Group for Mining and Energy, which became a nationwide platform for substantive discussion and shaping opinions on the transformation of the Polish energy sector, including the development of renewable energy sources (RES).
